## WATER TANKERS FOR APPROVAL

A \$25 deposit is payable for each filling station access key. Payment must occur before the application can be approved. If payment is made by cheque, please make reference to 'Recycled Water Key Deposit' and ensure the name of the company is on the cheque. Payment can be made in person at Central Coast Council or by mail. If submitting this application form by email, you will be able to pay by credit card during the application approval process.

Note: Every tanker will be inspected and issued a Compliance Certificate prior to being allowed to cart recycled water. Each driver will receive a recycled water site induction before being allowed access to Delivery Point filling stations. Inductions are required at each of the Delivery Point filling stations.

You will be asked to complete an Avdata System – Sale of Keys form, which registers the user for billing purposes. Avdata filling station access key(s) will only be issued at that time. A separate Avdata System – Sale of Keys form must be completed for each Avdata key issued. Only authorised representative(s) of the water carrier can sign the Avdata form.

Other tankers and / or drivers must be added as required, by completing and submitting another Application for Approval, requesting an amendment of the approval.
