<p><b>SUBSTANCES PROHIBITED FROM BEING DISCHARGED TO THE SEWERAGE SYSTEM</b></p> <p>The following substances are prohibited from being discharged to the sewerage system:</p> <ul style="list-style-type: none"> <li>• organochlorine weedicides, fungicides, pesticides, herbicides and substances of a similar nature and/or wastes arising from the preparation of these substances</li> <li>• organophosphorus pesticides and/or waste arising from the preparation of these substances</li> <li>• any substances liable to produce noxious or poisonous vapours in the sewerage system</li> <li>• organic solvents and mineral oil</li> <li>• any flammable or explosive substances</li> <li>• discharges from 'Bulk Fuel Depots'</li> <li>• chromate from cooling towers</li> <li>• natural or synthetic resins, plastic monomers, synthetic adhesives, rubber and plastic emulsions</li> <li>• rain, surface, seepage or subsoil water, unless specifically permitted</li> <li>• solid matter</li> <li>• any substance assessed as not suitable to be discharged to the sewerage system</li> <li>• waste liquids that contain pollutants at concentrations which inhibit the sewage treatment process – refer <i>National Wastewater Source Management Guideline, July 2008, WSAA</i></li> <li>• any other substances listed in a relevant regulation.</li> </ul>
